Dear Honorable Martire, Wambli Gleska Society Members, and Dignitaries,

The Rosebud Sioux Tribe understands the importance of international governmental relationships with the Italian government and other member governments of the AICCRE. The Rosebud Sioux Tribe also acknowledges all 27 (twenty seven) Articles of Friendship previously signed with the communities of the Italian Provinces.

It is the wish of the Rosebud Sioux Tribe to continue our International Governmental Relationships with the Italian Government and European Communities. It is in the best interest of the Rosebud Sioux Tribe to further our governmental relationships. The Rosebud Sioux Tribe will work exclusively with the Wambli Gleska Society per Rosebud Sioux Tribal Resolution 98-43. No other organization, society or public group will have this power or authorization to do such work without the written consent of the Rosebud Sioux Tribe. To date, the Rosebud Sioux Tribe has granted this authorization only to the Wambli Gleska Society.

The procedural certification of authorized tribal members or representatives of the Rosebud Sioux Tribe who wish to solicit or subscribe to monetary or material donations or assistance may do so with the following documentation. The individual must have a letter of authorization clearly signed and dated by the Rosebud Sioux Tribal Chairman and Treasurer detailing what the funds received will be used for and what Tribal Account this monetary contribution will be directed to. All monetary donations must never be in the direct form of currency but presented in the form of a bank draft, money order or certified check.

To further expedite all incoming mail, requests or facsimiles the Rosebud Sioux Tribe has designated Mr. Lewis Good Voice Eagle, Planner & Grant Writer of the Rosebud Sioux Tribe Resource and Economic Development Office as primary liaison. In Mr. Good Voice Eagle's absence Mr. Ted Felix will act in his capacity. All incoming postal mail, facsimile and telephone calls will be disseminated and directed to the proper authority by Mr. Good Voice Eagle.
